RESOLUTION NO. 197

A RESOLUTION AMENDING RESOLUTION NUMBERS 8 AND 144 SERIES OF 1986 AND 1987, RESPECTIVELY AND ASSIGNING DISTRICT NO. VI COMPRISING BARANGAYS AIRPORT, CONCEPCION, DAYHAGAN, JUATON, LILO-AN, LUNA, NASUNOGAN, NUEVA VISTA, AND SALVACION TO BE TAKEN OVER BY THE HONORABLE NEPOMUCENO P. APARIS I AND DISTRICT VII COMPRISING BARANGAYS OF CURVA, DOMONAR, ESPERANZA, GREEN VALLEY, LICUMA, MABATO, MAS-IN, R. M. TAN, AND SAN VICENTE WILL BE ASSIGNED TO THE HONORABLE CELSO P. ADOLFO AND DISTRICT VIII COMPRISING THE BARANGAYS OF BALION, BAYOG, CABULIHAN, CAGBUHANGIN, CATMON, GUINTI-GUI-AN, SAN JOSE, AND SABANG BAO WILL BE ASSIGNED TO THE HONORABLE SIXTO T. PONGOS.

"WHEREAS, we have now three (3) new Members (Mga Kagawad) of this august Body who have not as yet been assigned to any representative district such that it behooves to reapportion Ormoc City into ten (10) representative districts in order that the new Members, Mga Kagawad Nepomuceno P. Aparis I, Celso P. Adolfo, and Sixto T. Pongos, can be given each a district;

"NOW THEREFORE, on motion of Kagawad Fiel, jointly seconded by Mga Kagawad Yrastorza, Salazar and Subingsubing; be it

"RESOLVED, to amend Resolution Nos. 8 and 144, Series of 1986 and 1987, respectively, so as to assign District VI to Honorable Nepomuceno P. Aparis I, District VII to Honorable Celso P. Adolfo and District VIII to Honorable Sixto T. Pongos, so that Districts VI, VII, and VIII would now read:

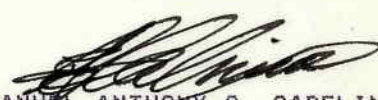
