RESOLUTION NO. 198

A RESOLUTION REQUESTING THE HONORABLE SECRETARY, DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS, MANILA, TO PROVIDE AT NO COST TO THE ORMOC CITY TECHNOLOGICAL MANPOWER TRAINING AND RESEARCH CENTER WHATEVER JUNK VEHICLES ARE AVAILABLE IN THE AREA V EQUIPMENT SERVICE DEPOT IN ORMOC CITY.

"WHEREAS, on March 18, 1987 this august Body passed and approved Resolution No. 190, among others, requesting Engineer Dometillo Silva, Head Auto Equipment Engineer to donate to the Ormoc City Technological, Manpower Training & Research Center whatever junked vehicles available to be used by the Ormoc City Technological, Manpower Training and Research Center in its training program;

"WHEREAS, on March 26, 1987 Engr. Dometillio C. Silva, had returned said resolution to this august Body, without action, for reason that it is not within their jurisdiction to dispense junk vehicles with suggestion that Resolution No. 190 should be revised and reworded and forwarded directly to the Honorable Secretary, Department of Public Works and Highways, Manila for proper dispensation, mentioning, among others, the number requested, the type, etc;

"NOW, THEREFORE, on motion of Kagawad Hermosilla; jointly seconded by Mga Kagawad Yrastorza and Subingsubing; be it


"RESOLVED, to request the Honorable Secretary, Department of Public Works and Highways, Manila, to provide at no cost to the Ormoc City Technological Manpower Training and Research Center six (6) units Ford Fiera, three (3) units IZUSU Dump Truck, three (3) units HINO Dump Truck, and three (3) units FUSO Dump Truck available in the Area V Equipment Service Depot in Ormoc City;
