RESOLUTION NO. 200

A RESOLUTION COMMENDING THE URMOC CITY FIRE DEPARTMENT FOR THEIR DARING AND HEROIC ACTION IN THEIR FIGHT AGAINST THE FIRE THAT TOOK PLACE LAST MARCH 27, 1987 DESTROYING THE RESIDENCE OF MRS. YGNACIO WHICH OTHERWISE COULD HAVE BROUGHT ALSO HAVOC TO THE NEIGHBORING HOUSES.

"WHEREAS, it is much understood that fire is very much an asset in our daily life when properly ulitilized but it is a destructive and deadly material in another way;

"WHEREAS, the fire that had rendered the dwelling of the Ygnacio Family, partially homeless and its properties totally gutted by fire on that fateful morning of Friday, March 27, 1987 as the head of the family was attending a teacher's meeting in school, and the children were either in their offices or in the classroom, had driven the family into total despair;

"WHEREAS, the Ygnacio's house and all its properties in the house could have been all eaten up by the fire if Ormoc City Firemen did not come to the rescue on time;

"WHEREAS, Ormoc City firemen bravely and relentlessly fought to put out the fire that was fast eating up Ygnacio's dwelling and being farmed to the neighboring house of the Obejas Family;

"NOW, THEREFORE, on motion of Kagawad Aparis, jointly seconded by Mga Kagawad Yrastorza and Subingsubing; be it

"RESOLVED, to commend the Ormoc City Fire Department for their daring and heroic action in their fight against the fire that took place last March 27, 1987 destroying the residence of Mrs. Ygnacio which otherwise could have brought also have to the neighboring houses;
