RESOLUTION NO. 203

A RESOLUTION THAT BARANGAY BAYOG (NOW DR. HERMENEGILDO COSTES SERAFICA PER ORDINANCE NO. 5 ON SAME DATE) BE INCLUDED IN THE PROGRAM OF LEYECO V FOR INSTALLATION OF POWER LINES TO SAID BARANGAY.

"WHEREAS, this august Body is in receipt of Resolution No. 2, Series of 1987 of the Sangguniang Pambarangay of Bayog, earnestly and respectfully soliciting the intercession of the Third Sangguniang Panlungsod ng Ormoc through the Honorable City Mayor, Emeterio V. Larrazabal, for the inclusion of Barangay Bayog in the program of LEYECO V of installation of power lines to Barangay Bayog;

"WHEREAS, said resolution states that the residents of Barangay Bayog desires urgently to avail of the services of LEYECO V in order to hasten the development of the barangay with the use of cheap electrical power and that the barangay council members have made their own surveys and have found out that it was nearer to tap their power from Barangay Sabang Bao;

"NOW, THEREFORE, on motion of Kagawad Pongos, seconded by Kagawad Hermosilla; be it






