"RESOLVED, to request the Management of LEYECO V to extend its power lines to Barangay Monterico;

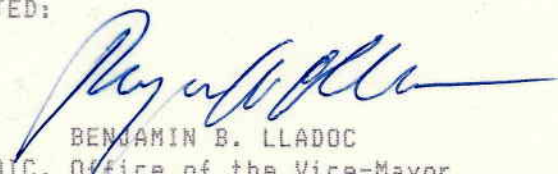

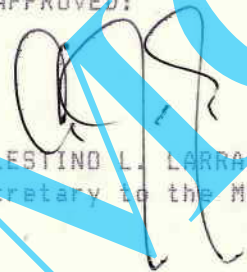
