LARRAZABAL TO GIVE HIS ASSISTANCE AND APPROVAL OF RESOLUTION-REQUEST OF ALTA VISTA AND TO REQUEST THE CITY SUPERINTENDENT OF SCHOOLS MISS CIRILA VILLEGAS TO ASSIGN TEACHERS OF SAID SCHOOL AND FURTHER TO REQUEST THE COMMITTEE ON FINANCE TO INCLUDE SAID SCHOOL BUILDING FOR APPROPRIATION IN THE 1988 ANNUAL BUDGET.

"WHEREAS, this august Body is in receipt of Resolution No. 4, Series of 1987 of the Barangay Council of Alta Vista earnestly and urgently requesting the august Members of the 3rd Sangguniang Panlungsod ng Ormoc through the Honorable OIC-City Mayor Emeterio V. Larrazabal, for a two-room school house and have said building constructed in Barangay Alta Vista and to assign teachers to said school;

"NOW, THEREFORE, on motion of Kagawad Fiel, jointly seconded by Kagawad Subingsubing, Salazar and Yrastorza; be it


"RESOLVED, to earnestly request the Honorable OIC-City Mayor Emeterio V. Larrazabal to give his assistance and approval of Resolution-request of Alta Vista and to request the City Superintendent of Schools Miss Cirila Villegas to assign teachers of said school and further to request the Committee on Finance to include said school building for appropriation in the 1988 Annual Budget;
