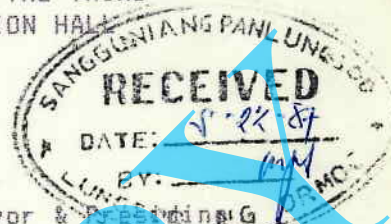

"NOW, THEREFORE, on motion of Kagawad Hermosilla, seconded by Kagawad Yrastorza; be it


