RESOLUTION NO. 220

WHEREAS; it has been observed that in other barangays which enjoys the blessings of electrical power there is marked increase in the progress and living standards of the residents;

WHEREAS; the constituents believe that with the installation of electrical power of barangay Catmon there will also be an increase of small industries which may help alleviate the problem of unemployment;
