RESOLUTION NO. 223

A RESOLUTION AUTHORIZING THE CITY TREASURER TO RELEASE THE SUM OF ONE THOUSAND SIX HUNDRED THIRTY-FOUR PESOS (P1,634.00) FROM THE EXISTING FUNDS OF BARANGAY CAMP DOWNES IN THE CITY TREASURY, THIS CITY TO BE MADE AVAILABLE FOR THE PURCHASE OF EIGHT (8) UNITS FLUORESCENT LAMPS FIXTURES, COMPLETE WITH WEATHER PROTECTORS AND MOUNTING BRACKETS TO BE INSTALLED AT THE HIGHWAY ALONG SAID BARANGAY TO REPLACE THE PRESENT EIGHT (8) UNITS 80-WATT, WITH THE 20-WATT FLUORESCENT LAMPS.

"WHEREAS, this august body is in receipt of a Resolution No. 32, Series of 1987 of the Barangay Council of Camp Downes, requesting to allocate eight (8) units of 20 watts fluorescent lamps in lieu of the eight (8) units of 80 watts mercury lamps for street lighting of Barangay Camp Downes;

"WHEREAS, Kagawad Hermosilla has appropriated P2,000.00 for the purpose;

"WHEREAS, upon consultation/verification with the City Budget Officer the existing funds available of Barangay Camp Downes is only P1,643.00;

"NOW, THEREFORE, on motion of Kagawad Hermosilla, seconded by Kagawad Subingsubing; be it

"RESOLVED, to authorize the City Treasurer to release the sum of One Thousand Six Hundred Thirty-Four Pesos (P1,634.00) from the existing funds of Barangay Camp Downes in the City Treasury to be made available for the purchase of eight (8) units fluorescent lamps fixtures, complete with weather protectors and mounting brackets to be installed at the highway along said barangay to replace the present eight (8) units 80-watt with the 20-watt fluorescent lamps;
