## RESOLUTION NO. 224

A RESOLUTION FAVORABLY RECOMMENDING THE ACCEPTANCE OF THE DONATION OF TWO (2) UNITS 20-WATT FLUORESCENT LIBITING FIXTURES FROM BARANGAY 14 DONATED TO THE CITY GOVERNMENT AND REQUESTING THE CITY MAYOR TO RECEIVE SAID DONATIONS AND TO NOTIFY THE CITY TREASURER THAT THE CONSUMPTION OF 40-WATT WILL BE BORNE BY THE CITY.

"WHEREAS, the Barangay Council of Barangay 14, in its Resolution No. 7, Series of 1987, has signified their intention to donate to the City Government of Ormoc two (2) units fluorescent lighting fixtures, 20 watts fluorescent lamps, 220 volts, complete with weather protector and mounting brackets and lead out wires with the request that the power consumption of said units will be borne by the city;

NOW, THEREFORE, on motion of Kagawad Hermosilla, jointly seconded by Mga Kagawad Aparis, Yrastorza and Subingsubing; be it

RESOLVED, to favorably recommend the acceptance of the donation of two (2) units 20-watt fluorescent lighting fixtures from Barangay 14 donated to the city government and requesting the City Mayor to receive said donations and to notify the City Treasurer that the consumption of 40-watt will be borne by the city;
