RESOLUTION NO. 229

A RESOLUTION STRONGLY SUPPORTING THE CLAIM FOR PAYMENT OF CODILLA'S ENTERPRISES WITH THE ECONOMIC SUPPORT FUND SECRETARIAT, OFFICE OF THE PRESIDENT OF THE PHILIPPINES, MALACANANG, MANILA IN THE AMOUNT OF P389,750.00 FOR THE CONSTRUCTION OF THE ESF HIGH SCHOOL BUILDING IN BARANGAY SAN JOSE, ORMOC CITY,

"WHEREAS, on May 4, 1987, the Honorable OIC-Mayor Emeterio V. Larrazabal sent a communication to Ms. Bernadette Estioko, Officer-In-Charge, Area 1V, ESF Secretariat, Office of the President of the Philippines, 17th Floor, Strata 100 Bldg., Emerald Ave., Pasig, Metro Manila, reiterating the claim of the Codilla's Enterprises in the amount of P389,750.00 for the construction of the ESF High School building in Barangay San Jose, Ormoc City considering that said building has been fully completed and operational over a year ago, but until now the contractor's innumerable representations to collect has failed;

"WHEREAS, in behalf of the city government of Ormoc, this august Body would like to reiterate the contractor's claim for payment for the good of public service;

"WHEREAS, a thousand or so student population of this barangay of San Jose has already availed of the ESF High School building;

"NOW, THEREFORE, on motion of Kagawad Pongos, jointly seconded by Nga Kagawad Yrastorza and Hermosilla; be it

"RESOLVED, to strongly support the claim for payment of Codilla's Enterprises with the Economic Support Fund Secretariat, Office of the President of the Philippines, Malacanang, Manila in the amount of P389,750.00 for the construction of the ESF High School Building in Barangay San Jose, Ormoc City, considering that said building has been

fully completed and operational;


