RESOLUTION NO. 232

A RESOLUTION REQUESTING THE HONORABLE DIC-CITY MAYOR EMETERIO V.
LARRAZABAL TO INTERCEDE FOR AND IN BEHALF OF THE FARMER-MEMBERS OF
THE AGRARIAN REFORM BENEFICIARIES ASSOCIATION (ARBA) OF BARANGAY
MACABUG FOR THE IMMEDIATE IMPLEMENTATION OF AN IRRIGATION PROJECT
IN BARANGAY MACABUG, ORMOC CITY.

"WHEREAS, Resolution No. 24, current series, of the Barangay Council of Macabug is requesting for the intercession of the Honorable OIC-City Mayor, through this august Body, for and in behalf of the Farmer-Members of the Agrarian Reform Beneficiaries Association (ARBA) in Barangay Macabug, Drmoc City for the immediate construction of the Macabug Irrigation Project to be installed in their area;

"WHEREAS, the farmers of Macabug who are ARBA Members have requested the National Irrigation Administration (NIA), Tacloban City in 1983 to construct an Irrigation Project in Macabug, Ormoc City;

"WHEREAS, Kagawad Rodolfo L. Rivilla, Jr. in his capacity as Kagawad In-Charge of Barangay Macabug manifested that he conferred with the Leader of the Agrarian Reform in Ormoc City and according to Mr. Romero the technical surveys in Macabug for the irrigation project have already been conducted by NIA Engineers sometime in 1984;

"WHEREAS, Res. No. 24 states that the National Irrigation Administration (NIA) Region VIII under the former Irrigation Director Manuel J. Salazar has approved the same and the NIA Regional Office had already calendared for its completion in 1984-85;

"WHEREAS, for about four years now or so the requested Irrigation Project in Macabug, Ormoc City have remained unimplemented, thereby causing low productivity in the area due to lack of irrigation facilities;

"RESOLVED, to request the Honorable OIC-City Mayor Emeterio V. Larrazabal to intercede for and in behalf of the Farmer-Members of the Agrarian Reform Beneficiaries Association (ARBA) for the immediate implementation of the Irrigation Project in Barangay Macabug, Ormoc City;

"RESOLVED, FURTHER, to furnish a copy of this resolution each to Her Excellency President Corazon C. Aquino, Malacanang, Manila; the Regional Director, National Irrigation Administration (NIA), Marasbaras, Palo, Leyte; the Regional Director Jose C. Llames, Department of Agrarian Reform (DAR), both in Tacloban City; and Mr. Esmael C. Romero, Team Leader of the Department of Agrarian Reform, Ormoc City for their information and reference and to the Barangay Council of Macabug, Ormoc City;
