RESOLUTION NO. 233

A RESOLUTION EARNESTLY REQUESTING THE HONORABLE OIC CITY MAYOR EMETERIO V. LARRAZABAL, THROUGH THE AUGUST MEMBERS OF THE 3RD SANGGUNANG PANLUNGSOD NG ORMOC, TO CAUSE THE CONSTRUCTION OF A BRIDGE FOR VEHICULAR TRAFFIC LEADING TO BARANGAY TAMBULILID, ORMOC CITY, AND TO CAUSE ALSO THE CONSTRUCTION OF A BARANGAY ROAD LINKING SAID BARANGAY TO THE REST OF THE CITY.

"WHEREAS, Barangay Tambulilid is the only urban barangay which is practically isolated from the city because it is located in an area bounded by a creek on the barangay Linao side and at the other areas by rice fields surrounding the barangay;

"WHEREAS, the existence of said condition renders the transportation of agricultural and other products to the markets very expensive and inconvenient due to the fact that vehicles cannot enter the barangay and if the only means of entering the barangay which is a creek negotiable only during low tide is used, considerable time is lost while waiting for the ideal time for the vehicle to cross;

"WHEREAS, the Barangay Council of Barangay Tambulilid, cognizant of the above-mentioned handicap of the barangay residents passed Resolution No. 6, Series of 1987 earnestly requesting the Hon. Emeterio V. Larrazabal through the honorable members of the 3rd Sangguniang Panlungsod Ng Ormoc to cause the construction of bridge leading to Barangay Tambulilid and to construct a barangay road linking the barangay to the rest of the city;

"NOW, THEREFORE, on motion of Kagawad Hermosilla, jointly seconded by Mga Kagawad Yrastorza and Adolfo; be it

"RESOLVED, to earnestly request the Honorable OIC City Mayor Emeterio V. Larrazabal, through the august Members of the 3rd


