RESOLUTION NO. 235-A

A RESOLUTION IMPLEMENTING THE HOUSE NUMBERING ORDINANCE (ORDINANCE  
NO. 2, DATED OCTOBER 19, 1976) IN ORMOC CITY.

"WHEREAS, on October 19, 1976 the then First Sangguniang Bayan (Panlungsod) passed and approved Resolution No. 191, embodying Ordinance No. 2, entitled, 'AN ORDINANCE TO NUMBER OR RENUMBER ALL HOUSES, BUILDINGS AND OTHER STRUCTURE AND THE LIKE IN THE POBLACION AND SUBURBS OF ORMOC CITY AT THE EXPENSE OF THE OWNERS OR DWELLERS THEREOF, PROVIDING PENALTIES FOR ITS VIOLATIONS';

"WHEREAS, for years now the house numbering ordinance has never been implemented;

"WHEREAS, we really have to implement this ordinance considering that complaints have been aired wherein many letters were sent back to the senders because they could not locate the addressees due to the absence of the house numbers, despite 5,000 number plates having already been procured and stored at the City Treasurer's Office;

"NOW, THEREFORE, on motion of Kagawad Hermosilla, jointly seconded by Mga Kagawad Yrastorza and Subingsubing; be it

"RESOLVED, to implement the house numbering ordinance (Ordinance No. 2, dated October 19, 1976) in Ormoc City;


