RESOLUTION NO. 237

A RESOLUTION EARNESTLY AND URGENTLY REQUESTING THE REGIONAL DIRECTOR
OF THE BUREAU OF POSTS, REGION VIII, TACLOBAN CITY, TO CAUSE THE
IMPROVEMENT OF THE SERVICE OF THE BARANGAY VALENCIA POST OFFICE.

"WHEREAS, an extension Post Office was established in Barangay
Valencia purposely to serve said Barangay and neighboring barangays
besides;

"WHEREAS, the Hon. Teofilo C. Baclohan, Punong Barangay of
Barangay Don Potenciano A. Larrazabal has manifested and conveyed the
sentiments of the residents and leaders of Barangays San Jose, Sabang
Bao, Labrador, Catmon, R.M. Tan, Maticaa, Brgy. Herminigildo Serafica,
Nueva Sociedad, Monterico, Brgy. Don Potenciano A. Larrazabal,
Cagbuhangin, Calubihan, Conception, Dayhagan, Juaton, Brgy. Kadaohan and
some barangays adjacent to Barangay Valencia that:

1. Whenever they go to the Post Office to transact business
there are days of the week when the Post Master is not in his
office and they have to wait until the afternoon and aside
from spending transportation and for meals, they still had to
go home without having consummated their purpose with the Post
Office;
2. That it has come to the attention of the residents that
whenever mail matter for Valencia is delivered, sometimes the
Post Master is not in his office and the mail matter is re-
routed which causes a delay of some days;
3. That the Post Master can not issue Postal Money Orders, nor
can he deliver letters as he is not a letter carrier;
4. That the residents prefer to come to the Ormoc Post Office
because even if they spend for the trip they are sure to be

served because there are always personnel at the Ormoc City Post Office;

5. That the residents and leaders prefer the former practice of Barangay Secretaries of fetching mail matter for their respective barangays provided they are given honorarium;

"WHEREAS, the Hon. Teofilo C. Baclohan has conveyed and solicited the aid of this movant to bring this matter to the attention of the proper authorities;

"NOW, THEREFORE, on motion of Kagawad Hermosilla, jointly seconded by Mga Kagawad Yrastorza and Subingsubing; be it

"RESOLVED, to earnestly request the Regional Director of the Bureau of Posts, Region VIII, to cause the improvement of the postal service at the Barangay Valencia Post Office;


RESOLVED, FURTHER, to furnish a copy of this resolution each to the Regional Director of the Bureau of Posts, Region VIII, Tacloban City; the Post Master General, Mr. Cirio Oscar Espos, Postal Inspector II, and the Post Master General at Manila.
