we are in receipt of Resolution No. 6, current series, "WHEREAS, of the Barangay Council of Nasunogan, requesting the City Government of Ormoc, through the Honorable City Mayor Emeterio V. Larrazabal to make representation with the Philphos-PASAR Water Supply Office (LWSS) for the tapping of water lines at its Salvacion source to Barangay Nasunogan;

WHEREAS, the installation for the deep well in their barangay did not solve the water problem because the water coming out from the deep well is not potable;
