RESOLUTION NO. 243

A RESOLUTION MOST RESPECTFULLY, EARNESTLY AND URGENTLY REQUESTING HER EXCELLENCY PRESIDENT CORAZON C. AQUINO TO INTERCEDE FOR THE HOLDING BACK OF THE PROJECTED PRICE INCREASE OF OIL PRODUCTS IN THE PHILIPPINES.

"WHEREAS, members of the Consumer Association of Ormoc City and numerous citizens have aired and vented their vehement complaints against the projected increase of oil products in the Philippines;

"WHEREAS, even if the price increase has not yet been implemented the prices of prime commodities has already risen to intolerable range thereby triggering a spate of complaints from the consuming public;

"WHEREAS, the rise in prices has spread consternation among all of the consuming public compounding the unstable economic situation of the city;

"WHEREAS, the consuming public has already manifested their sufferings through mass media and personally has taken up their complaints and demanding action from the local administration regarding the matter;

"NOW, THEREFORE, on motion of Kagawad Fiel, seconded by Mga Kagawad Hermosilla and Subingsubing; be it

"RESOLVED, to most respectfully, earnestly and urgently request Her Excellency, Corazon C. Aquino, President, Republic of the Philippines, to intercede for the holding back of the projected increase of oil products in the Philippines;


"RESOLVED, FURTHER, to furnish a copy of this resolution each to Her Excellency President Corazon C. Aquino, Malacanang and the Members of the Energy Regulatory Board, at Manila;

"CARRIED. Four (4) affirmative votes; three (3) against, registered by Mga Kagawad Pongos, Salazar and Adolfo; two (2) abstention registered by Mga Kagawad Yrastorza and Rivilla;
