RESOLUTION NO. 244

A RESOLUTION ADOPTING RESOLUTION NO. 1, DATED JULY 14, 1987 OF THE BARANGAY COUNCIL AND PTA OFFICIALS OF LINAO COMMUNITY SCHOOL OF BARANGAY LINAD SO AS TO REQUEST THE DIFFERENT GOVERNMENT AGENCIES RESPONSIBLE FOR THE REPAIR OF THE OLD PTA SCHOOL BUILDING, BPW BUILDING, NURSERY AND TOILET.

Barangay Council and PTA Officials of the Linao Community School of Barangay Linao, this City in their Resolution No. 1, "WHEREAS, dated July 14, 1987 has requested this august Body to assist said barangay by way of passing resolution earnestly requesting the different government agencies responsible in the repair of the old PTA School Building, BPW Building, Nursery and Toilet which are badly dilapidated Building, BPW Building, Nursery and Toilet which are badly dilapidated in order to solve the problem of giving safety to school children and avoid overcrowding of classes;

"WHEREAS, upon ocular inspection by the PTA Officials it had been found out that said school buildings are already dilapidated considering that they are of after liberation World War II vintage;

"WHEREAS, aside from the existing dilapidated school buildings, the Linao Community School, also needs additional classrooms for the increase enrolment every school year;

"NOW, THEREFORE, on motion of Kagawad Salazar, jointly seconded by Mga Kagawad Subingsubing, and Hermosilla; be it

"RESOLVED, to adopt Resolution No. 1, dated July 14, 1987 of the Barangay Council and PTA Officials of Linao Community School of Barangay Linao so as to request the different government agencies responsible for the repair of the old PTA School Building, BPW Building, Nursery and Toilet which are badly dilapidated in order to solve the problem of giving safety to school children and avoid overcrowding of classes;
