

RESOLUTION NO. 245

A RESOLUTION TO AMEND RESOLUTION NO. 223, CURRENT SERIES, SO AS TO CHARGE THE AMOUNT OF ONE THOUSAND SIX HUNDRED THIRTY-FOUR PESOS (P1,634.00) TO WHATEVER FUNDS AVAILABLE IN THE CITY BUDGET OFFICE, INSTEAD OF CHARGING IT TO BARANGAY CAMP DOWNES, PURSUANT TO SAID RESOLUTION.

"WHEREAS, on June 3, 1987 we passed and approved Resolution No. 223, current series, authorizing the City Treasurer to release the sum of One Thousand Six Hundred Thirty-Four Pesos (P1,634.00) from the existing funds of Barangay Camp Downes in the City Treasury, this city to be made available for the purchase of eight (8) units fluorescent lamps fixtures, complete with weather protectors and mounting brackets to be installed at the highway along said barangay to replace the present eight (8) units 80-watt mercury lamps with the 20-watt fluorescent lamps;

"WHEREAS, said resolution was wrong and inconsistent because it did not serve truly the purpose, considering that the amount appropriated was charged to Barangay Camp Downes' funds which should not be;

"NOW, THEREFORE, on motion of Kagawad Hermosilla, jointly seconded by Mga Kagawad Fiel and Yrastorza; be it

"RESOLVED, to amend Resolution No. 223, current series of this august Body, so as to charge the amount of One Thousand Six Hundred Thirty-Four Pesos (P1,634.00) to whatever funds available in the City Budget Office, instead of charging it to Barangay Camp Downes' funds, pursuant to said resolution;




