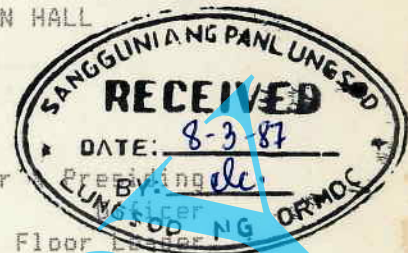

RESOLUTION NO. 249

A RESOLUTION TO AUTHORIZE THE CITY MAYOR TO WITHDRAW FUNDS FROM THE SPECIAL DEVELOPMENT ACCOUNT WITH THE DEPARTMENT OF LOCAL GOVERNMENT IN THE AMOUNT OF SEVEN HUNDRED TWENTY THOUSAND PESOS (P720,000.00) FOR THE PURCHASE OF WATERMETERS FOR THE ORMOC WATERWORKS SYSTEM.

"WHEREAS, the City of Ormoc has funds on deposit with the Department of Local Government (DLG) in the Special Development Account (SDA);

"WHEREAS, the City of Ormoc is complying fully with the terms and conditions stipulated in the DLG/ SDA Withdrawal Agreement;

"WHEREAS, the City of Ormoc now desires to avail of their Special Development Account Fund;


"NOW, THEREFORE, on motion of Kagawad Yrastorza, jointly seconded by Mga Kagawad Hermosilla, Rivilla and Aparis; be it


"RESOLVED, to authorize the Honorable City Mayor Emeterio V. Larrazabal to withdraw funds from the Special Development Account of the Department of Local Government (DLG) in the amount of Seven Hundred Twenty Thousand (P720,000.00) to be expended for the purchase of watermeters for the Ormoc Waterworks System;

"RESOLVED, FURTHER, that copies of this resolution be furnished to the Honorable Secretary of Local Government, DLG, Metro Manila; the City Development Coordinator; the City Engineer; the City Treasurer; and the City Auditor, all in Ormoc City for their information and guidance;


"CARRIED UNANIMOUSLY."


