RESOLUTION NO. 250

A RESOLUTION EARNESTLY REQUESTING THE HONORABLE OIC CITY MAYOR EMETERIO V. LARRAZABAL TO GIVE HIS FAVORABLE ASSISTANCE AND APPROVAL ON RESOLUTION NO. 1, SERIES OF 1987, OF THE BARANGAY COUNCIL OF LIBERTY BY DIRECTING THE WATERWORKS SUPERINTENDENT ENGR. NESTOR PENSERGA, TO CAUSE THE ESTIMATE OF THE SOURCE OF POTABLE WATER AND ALSO, TO REQUEST THE CITY SUPERINTENDENT OF SCHOOLS MISS CIRILA VILLEGAS TO ASSIGN ONE ADDITIONAL TEACHER AT LIBERTY COMMUNITY SCHOOL AND TO FURTHER, REQUEST THE COMMITTEE ON INFRASTRUCTURE TO INCLUDE THE CONSTRUCTION OF ADDITIONAL SCHOOL BUILDING FOR CALENDAR YEAR 1988 INFRASTRUCTURE FUND BUDGET.

"WHEREAS, the Barangay Council of Liberty in its Resolution No. 1, Series of 1987 has earnestly and urgently requested the Honorable OIC City Mayor Emeterio V. Larrazabal, through this august Body, to cause the resolution of the problem of the supply of safe potable water to be taken from a spring and the construction of a school building to house the large school population and the assignment to the barangay of another 2 teachers or as the Department of Education, Culture and Sports may deem necessary, to take care of Grades 2,3,4 and 5;

"WHEREAS, said resolution states that Barangay Liberty, since time immemorial has been drinking water taken from only one source which has been discovered by personnel from the City Health Department to be unsafe for drinking and has bacteria and germs which has been causing the numerous spate of intestinal and other waterborne diseases and deaths, specially among children;

"WHEREAS, there is an existing spring located above the barangay but it needs a reservoir and necessary piping to the barangay at a distance of 1 kilometer;

(RES. NO. 250)

"WHEREAS, Barangay Liberty needs also a school building and teachers to be assigned thereat, because the present population of the Barangay Community School has almost 50 pupils in grade 1 and almost the same in grade 2 and grades 3, 4 and 5 have sporadic classes considering the physical impossibility of only 1 teacher teaching all the grades;

"NOW, THEREFORE, on motion of Kagawad Rivilla, jointly seconded by Mga Kagawad Hermosilla and Subingsubing; be it

"RESOLVED, to earnestly request the Honorable OIC City Mayor Emeterio V. Larrazabal to give his favorable assistance and approval of Resolution No. 1, Series of 1987, of the Barangay Council of Liberty by:


- a) Directing the Waterworks Superintendent Engr. Nestor Penserga to cause the estimate of the source of potable water;
- b) Requesting the City Superintendent of Schools, Miss Cirila Villegas to assign one additional teacher in Liberty Community School; and
- c) Requesting, further the Committee on Infrastructure to include the construction of additional school building for CY 1988 Infrastructure Fund Budget.


"RESOLVED, FURTHER, to furnish a copy of this resolution each to His Honor, OIC-City Mayor Emeterio V. Larrazabal for his favorable assistance and approval, the Division Superintendent of Schools, the Waterworks Superintendent, and the Committee on Infrastructure, through its Chairman, Sangguniang Panlungsod, all in Ormoc City;

"CARRIED UNANIMOUSLY."


