RESOLUTION NO. 254

A RESOLUTION AUTHORIZING THE CITY TREASURER TO CHARGE AGAINST CURRENT APPROPRIATION ON ACQUISITION OF ROAD-RIGHTS-OF-WAY OF THE INFRASTRUCTURE FUND THE SUM OF FOUR THOUSAND TWO HUNDRED FORTY-FOUR PESOS (P4,244.00) TO BE MADE AVAILABE FOR PAYMENT OF THE RROW CLAIM OF MR. MANUEL VELOSO FOR LOTS NOS. 8455-A, 66 SQUARE METERS AT P60.00 PER SQUARE METER AND 8455-B, 71 SQUARE METERS AT P4.00 PER SQUARE METER, PER APPRAISAL BASED ON THE 1978 SCHEDULE OF MARKET VALUES, SITUATED IN BARANGAY VALENCIA, AND, ALSO, AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN THE DEED OF ABSOLUTE SALE COVERING THESE LOTS, FOR AND IN BEHALF OF THE CITY GOVERNMENT OF GRMOC.

"The Sangguniang Panlungsod ng Ormoc, on motion of Kagawad Salazar, jointly seconded by Mga Kagawad Fiel and Subingsubing; be it

to authorize the City Treasurer to charge against "RESOLVED, current appropriation on Acquisition of Road-Rights-of-way of the Infrastructure Fund the sum of Four Thousand Two Hundred Forty-Four Pesos (P4,244.00), said sum or so much thereof as may be necessary, to be made available for payment of RROW claim of Mr. Manuel Veloso, as follows:
