RESOLUTION NO. 255

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO ACCEPT THE DONATION FROM BARANGAY 14 OF FIVE (5) UNITS FLUORESCENT LIGHTING FIXTURES, 20-WATT, 220-VOLT COMPLETE WITH ACCESSORIES TO BE INSTALLED AT STRATEGIC PLACES OF BARANGAY 14, AND TO NOTIFY THE CITY TREASURER THAT SAID BARANGAY DESIRES TO AVAIL OF THE 250-WATT PRIVILEGE WHICH IS TO BE PAID BY THE CITY IN CONSONANCE TO RESOLUTION NO. 1149 DATED APRIL 20, 1982.

"WHEREAS, Resolution No. 9, current series, of the Barangay Council of Barangay 14 has signified its intention to donate to the City Government of Ormoc five (5) units fluorescent lighting fixtures, complete with weather protectors and mounting bracket, 20-watt, 220volt, complete with lead out wires to be installed at strategic places said barangay, with the supplication that the power consumption of said units be borne by the city;

Barangay 14 states that in order to forestall the "WHEREAS. commission of crimes against persons and properties it has bought five (5) units fluorescent lighting fixtures for installation at strategic places in said barangay;

"NOW, THEREFORE, on motion of Kagawad Hermosilla, jointly seconded by Mga Kagawad Aparis and Salazar; be it

(RES. NO. 255)

"RESOLVED, to authorize the Honorable City Mayor to accept the donation of five (5) units lighting fixtures, 20-watt, 220-volt, complete with accessories to be installed at strategic places of Barangay 14, and to notify the City Treasurer that said barangay wants to avail of the 250-watt privilege which is to be paid by the city in consonance to Resolution No, 1149 dated April 20, 1982.
