RESOLUTION NO. 257

A RESOLUTION URGING THE POLICE STATION COMMANDER AND THE CITY JAIL WARDEN, BOTH OF THE ORMOC CITY INP AND THE CITY FISCAL TO CONDUCT A THOROUGH INVESTIGATION OF THE GORY INCIDENT THAT HAPPENED INSIDE THE ORMOC CITY JAIL LAST MONDAY EVENING, AUGUST 3, 1987, RESULTING IN THE DEATH OF ONE INMATE AND INJURIES TO THREE OTHERS.

"WHEREAS, everybody is aware of the gory incident that happened inside the Ormoc City Jail last Monday evening, August 3, 1987 resulting in the death of one inmate and injuries of three others;

"WHEREAS, it was not immediately known what caused the incident considering that the Chairman on Police Fire and Public Safety, chaired by Honorable Nepomuceno P. Aparis, did not receive any feed-back or report of the incident from the Police Station Commander;

"WHEREAS, it behooves this august Body to urge the Police Station Commander and his City Jail Warden and also the City Fiscal to conduct thorough investigation in aid to proper legislation;

"WHEREAS, if circumstances warrant to file appropriate criminal charges against those persons responsible for said incident;

"NOW, THEREFORE, on motion of Kagawad Aparis, jointly seconded by Mga Kagawad Fiel, Salazar and Subingsubing; be it


"RESOLVED, to urge the Police Station Commander and City Jail Warden both of Ormoc City INP and the City Fiscal to conduct a thorough investigation of that gory incident which happened inside the Ormoc City Jail last Monday evening, August 3, 1987, resulting in the death of one inmate and injuries of three others and if circumstances warrant to file appropriate criminal charges against those persons responsible for said incident;
