RESOLUTION NO. 259

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR EMETERIO V. LARRAZABL TO RECEIVE THE DONATION FROM BARANGAY 29 OF NINE (9) UNITS FLUORESCENT LIGHTING FIXTURES, 20 WATTS, 220 VOLTS COMPLETE WITH ACCESSORIES AND TO REQUEST THE LEYECO V TO INSTALL WIRINGS TO BE TAPPED TO THE MAINLINE, WITH A REQUEST TO AVAIL OF THE PRIVILEGE THAT THE POWER CONSUMPTION BE BORNE BY THE CITY GOVERNMENT, SUBJECT TO LIMITATION AS MANDATED BY RESOLUTION NO. 1149 DATED APRIL 20, 1982.

"WHEREAS, this august Body is in receipt of Resolution No. 1, Series of 1987 of the Barangay Council of Brgy. 26, among others, earnestly requesting the Sangguniang Panlungsod ng Ormoc to authorize the Honorable Emeteric V. Larrazabal to receive a donation of nine (9) sets fluorescent lighting fixtures, 20 watts, 220 volts with the request that the Honorable Members of the Sangguniang Panlungsod make representations to the Management of LEYECO V to install wirings to these units and tap it to the mainline and that, finally, requesting that the privilege that the power consumption be borne by the city government;

"WHEREAS, said resolution states that Sitio Isla Verde of Barangay 26 has procured already nine (9) units fluorescent lighting fixtures which they desire to install at said sitio;

"WHEREAS, it is also stated that due to absence of connections to the mainline said lights have been installed but connected to private lines which has manifested that they do not want said connections because of the bills which will be indicated in their respective meters;

"WHEREAS, considering that these lights are barangay lights and the residents desires to avail of the right or privilege to have the power bills paid by the city to no more than 250 watts;

'NOW, THEREFORE, on motion of Kagawad Hermosilla, jointly seconded by Mga Kagawad Rivilla and Yrastorza; be it
