RESOLUTION NO. 260

A RESOLUTION REQUESTING THE MANAGEMENT OF LEYECO V THAT THE RATE CHARGED TO THE CITY GOVERNMENT FOR POWER CONSUMPTION OF THE CITY PROPER AND BARANGAY STREET LIGHTING BE REDUCED TO A TOLERABLE LEVEL.

"WHEREAS, Kagawad Pongos manifested that in their meeting of Department Heads last August 1, 1987, it was mentioned in the discussion that light bills of the city is almost unbearable and enormous and in consonance thereto Kagawad Adolfo suggested that if possible we can request Leyeco V to grant the city a special rate, a lower rate than what they are actually charging now;

"WHEREAS, Kagawad Hermosilla, also manifested that as of March, 1987 we are billed for the street lighting alone, the amount of P25,702.77. Including the other bills it might rise up to P200,000.00, i.e., only one month;

"WHEREAS, this august Body finds it imperative to respectfully request the Management of Leyeco V to reduce the power rate of the City Proper and Barangay Street Lighting to a tolerable level;

"NOW, THEREFORE, on motion of Kagawad Pongos, jointly seconded by Mga Kagawad Adolfo, Aparis and Subingsubing; be it

"RESOLVED, to request the Management of Leyeco V that the rate charged to the City Government for power consumption of the City Proper and Barangay Street Lighting be reduced to a tolerable level;
