RESOLUTION NO. 261

DIRECTOR OF PRISONS, NATIONAL A RESOLUTION REQUESTING THE PENITENTIARY BUILDING, MUNTINGLUPA, METRO MANILA, TO SEND A MEMORANDUM TO THE JAIL WARDEN, OR MOC CITY JAIL TO SEND OR TRANSPORT CONVICTED PRISONERS PRESENTLY DETAINED AT THE ORMOC CITY JAIL TO THE LEYTE REGIONAL PRISON, ABUYOG, LEYTE INSTEAD OF TO THE NEW BILIBID PRISON, MUNTINGLUPA, METRO MANILA.

"WHEREAS, transporting of convicted prisoners from Ormoc City Jail to the New Bilibid Prison, Muntinglupa, Metro Manila is a problem to the City Jail Warden because of lack of funds;

"WHEREAS, there is a correctional institution created by the Bureau of Prisons at Abuyog, Leyte known as the Leyte Regional Prison which is more or less 100 kilometers away from the City of Ormoc;

financial problems in transporting these convicted "WHEREAS, prisoners will be minimized if these prisoners can be sent to the said eyte Regional Rrison, Abuyog, Leyte;

"WHEREAS, the Leyte Regional Prison at Abuyog, Leyte also affords opportunity to members of the family and friends of the convicted prisoners to visit them thus such visits from family and friends being considered an important factor in rehabilitating convicts;

"WHEREAS, this request is being made in order to solve the congestion of the Ormoc City Jail;

"NOW, THEREFORE, on motion of Kagawad Aparis, jointly seconded by Mga Kagawad Rivilla and Subingsubing; be it

to request the Director of Prisons, National "RESOLVED, Penitentiary Building, Muntinglupa, Metro Manila to send a Memorandum to the Jail Warden, Ormoc City Jail to send or transport convicted prisoners presently detained at the Ormoc City Jail to the Leyte Regional Prison, Abuyog, Leyte, instead of to the New Bilibid Prison,
