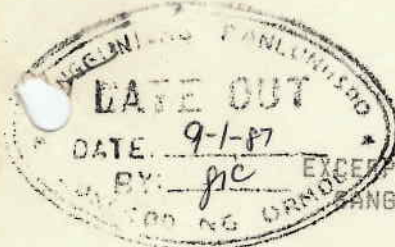

RESOLUTION NO. 264

A RESOLUTION EARNESTLY REQUESTING THE NATIONAL OFFICE, INP MANILA, TO  
SEND IMMEDIATELY THE AMOUNT OF P20,000.00 TO THE INP, ORMOC CITY TO  
TAKE CARE OF TRANSPORTATION OF PRISONERS DUE TO THE OVERCROWDING OF  
THE ORMOC CITY JAIL RESULTING IN RESTIVENESS AMONG THE INMATES.

"WHEREAS, Sgt. Wilfredo Tomakin, Jail Warden, appeared before this  
august Body and manifested that the City Jail of Ormoc has accommodated  
94 prisoners, already beyond the 50 prisoners limitation thereby making  
it congested;

"WHEREAS; the Jail Warden also, manifested that he has already  
prepared a tentative plan which he submitted to their Station Commander  
categorizing 24 insular prisoners into two, so that they only have to  
transport twelve (12) hardened criminals whose sentences ranges from six  
years up;

"WHEREAS, this august Body finds it imperative to request the  
National Office, INP Manila to send the amount of P20,00.00 needed for  
the immediate transport of these 12 hardened prisoners in order to  
lessen the congestion of the City Jail in Ormoc City;

"NOW, THEREFORE, on motion of Kagawad Hermosilla, seconded by  
Kagawad Salazar; be it

"RESOLVED, to earnestly request the National Office, INP Manila,  
to send immediately the amount of P20,000.00 to the INP, Ormoc City, to  
take care of transportation of prisoners due to the overcrowding of the  
Ormoc City Jail resulting in restiveness among the inmates;
