RESOLUTION NO. 274

A RESOLUTION FAVORABLY ENDORSING THE REQUEST OF BARANGAY MABATO FOR THE OPENING OF PRIMARY SCHOOL BEGINNING SCHOOL YEAR 1988.

"WHEREAS, Resolution No. 2, current series, of the Barangay Council of Mabato, among others, requesting the City government thru this august Body, 3rd Sangguniang Panlungsod ng Ormoc, to cause the opening of primary school at Barangay Mabato, Ormoc City;

"WHEREAS, said resolution states that Barangay Mabato, a duly constituted barangay has no primary school at present, wherein the school children have to walk about three (3) kilometers to the nearest school in the area to attend classes;

"WHEREAS, the barangay has sufficient number of school children that may warrant the opening of primary school;

"WHEREAS, the officials and residents of the barangay are willing to donate the site of school in accordance with the requirement of the Department of Education, Culture and Sports;

"WHEREAS, Kagawad Adolfo manifested that there is already a lot to be donated for school site purposes;

"NOW, THEREFORE, on motion of Kagawad Adolfo, jointly seconded by Mga Kagawad Hermosilla and Salazar; be it

"RESOLVED, to favorably endorse the request of Barangay Mabato, per its Resolution No. 3, dated August 1, 1987, for the opening of primary school beginning school year 1988;

"RESOLVED, FURTHER, to furnish a copy of this resolution each to the Division Superintendent of Schools, DECS, the City Treasurer, and the Barangay Council of Mabato, all in Ormoc City.
