RESOLUTION NO. 277

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR, EMETERIO V. LARRAZABAL, IN BEHALF OF THE TEACHERS OF THE SAN ANTONIO COMMUNITY SCHOOL TO SIGN ROAD-RIGHT-OF-WAY AGREEMENT AND TO RECEIVE PAYMENT FOR THE REPLACEMENT OF ALL SCHOOLS IMPROVEMENT DESTROYED AS A RESULT OF THE ROAD WIDENING OF THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS, REGION VIII.

"WHEREAS, this august Body is in receipt of Resolution No. 2, Series of 1987 of the joint meeting of the San Antonio, Parent-Teachers Association and the Barangay Council of San Antonio, earnestly requesting payments of school fence, pergola, toilet, and industrial arts buildings, and authorizing Mrs. Magdalena C. Delgado to negotiate, sign road-right-of-way documents, collect cash amount with PNB, and sign papers relative thereto if any, with the Department of Public Works and Highways, Region VIII, in connection with the West Leyte Road Improvement project package II along Ormoc-Albuera road;

"WHEREAS, this august Body is of the opinion that only the Honorable City Mayor of Ormoc shall have the authority to sign any agreement, for and in behalf of the City Government of Ormoc being a policy determining matter;

"NOW, THEREFORE, on motion of Kagawad Rivilla, jointly seconded by Mga Kagawad Hermosilla and Aparis; be it

"RESOLVED, to authorize the Honorable City Mayor, Emeteric V. Larrazabal, in behalf of the teachers of the San Antonio Community School to sign Road-Right-of-Way Agreement and to receive payment for the replacement of all schools improvement destroyed as a result of the road widening of the Department of Public Works and Highways, Region VIII:

"RESOLVED, FURTHER, to furnish a copy of this resolution each to the Regional Director, Department of Public Works and Highways, 8th DPWH

Regional Office, Candahug, Palo, Leyte; the Honorable City Mayor; the Highway District Engineer, DPWH; and the City Engineer, Ormoc City;
