RESOLUTION NO. 278

A RESOLUTION EARNESTLY REQUESTING THE NATIONAL GOVERNMENT FOR A BUDGETARY AID TO THE CITY OF ORMOC IN ORDER TO MEET THE EXIGENCY OF FUNDS AND TO MEET THE DEMANDS OF THE SECONDARY AND ELEMENTARY SCHOOL TEACHERS IN THE AMOUNT OF P1,400,000.00.

"WHEREAS, Kagawad Subingsubing manifested that in their meeting last Saturday September 26, 1987 with the Officers of the Ormoc City Public School Teachers, it was agreed to ask a budgetary aid from the national government to cover up the benefits which the city has been giving to the secondary and elementary school teachers, such as additional living allowance, hazard pay, honorarium of non-formal teachers;

"WHEREAS, it is imperative to ask this amount from the higher authority concerned to meet the exigency of funds and demand of the teachers in Ormoc City;

"WHEREAS, Rule 4.1 of DECS Order No. 78, s. 1987 states that "There shall be no diminution/reduction in all existing compensation received by public secondary school teachers as a result of their nationalization. Neither will the existing additional benefits/local public elementary school teachers funded by local governments/local school boards be discontinued or reduced ...";

"NOW, THEREFORE, on motion of Kagawad Subingsubing, severally seconded by Mga Kagawad Hermosilla, Aparis and Fiel; be it


"RESOLVED, to earnestly request the national government for a budgetary aid to the City of Ormoc in order to meet the exigency of funds and to meet the demands of the secondary and elementary school teachers in the amount of P1,400,000.00;

"RESOLVED, FURTHER, to furnish a copy of this resolution each to Hon. Lourdes R. Quisumbing, Secretary of Education, Culture and Sports; the Regional Director, DECS, Tacloban City; the Division Superintendent of Schools, Ormoc City;
