RESOLUTION NO. 282

A RESOLUTION EARNESTLY REQUESTING THE DEPARTMENT OF BUDGET AND MANAGEMENT FOR THE AVAILMENT OF THE LOCAL GOVERNMENT REVENUES STABILIZATION FUNDS (LGRSF) FOR THE IMPROVEMENT OF THE CITY JAIL IN THE AMOUNT OF P250,000.00

"WHEREAS, the Ormoc City Jail was originally designed to house 50 inmates but actually is now housing 96 inmates which is already beyond its capacity thereby resulting in overcrowding which triggers frayed tempers and unsanitary conditions;

"WHEREAS, said jail does not have any provisions for separate cells for females and minors;

"WHEREAS, there is now being prepared by the City Engineer a Program of Work, Plans and Estimates for the proposed two-storey City Jail building amounting to P249,989.12;

"NOW, THEREFORE, on motion of Kagawad Aparis, unanimously seconded; be it


"RESOLVED, to earnestly request the Department of Budget and Management for the availment of the Local Government Revenues Stabilization Funds (LGRSF) for the improvement of the City Jail in Ormoc city in the amount of P250,000.00;

"RESOLVED, FURTHER, to furnish a copy of this resolution each to the Honorable Secretary of Budget & Management, Manila, for his consideration and immediate approval; the Honorable City Mayor; the City Budget Officer; the City Treasurer and the City Engineer, all in Ormoc City;




