## RESOLUTION NO. 283

A RESOLUTION EARNESTLY REQUESTING THE DEPARTMENT OF BUDGET AND MANAGEMENT FOR THE AVAILMENT OF THE LOCAL GOVERNMENT REVENUES STABILIZATION FUNDS (LGRSF) FOR THE CONSTRUCTION OF THE PUBLIC MARKET ADMINISTRATION TWO-STOREY BUILDING AMOUNTING TO P250,000.00 AND COLD STORAGE BUILDING AMOUNTING TO P250,000.00 RESPECTIVELY.

"WHEREAS, the market administration occupies a stall area in the public market which is already cropped-up and congested;

"WHEREAS, the public market has no cold storage building so much so that Alfors (Wholesalers) have to go to Tacloban City to dispose their stock of fish and causing congestion and unsanitation in the street of the market because Fish vendors are forced to sell all their fish before they become stale;

"WHEREAS, there are now being prepared by the City Engineer Program of Work, Plans and Estimates of the proposed Public Market two-storey building amounting to P250,000.00 of which money shop will be located in the first floor and should be leased and the second floor will be the administration office and Cold Storage building amounting to P250,000.00 respectively;

"NOW, THEREFORE, on motion of Kagawad Yrastorza, seconded by Kagawad Hermosilla; be it

"RESOLVED, to earnestly request the Department of Budget and Management for the availment of the Local Government Revenues Stabilization Funds (LGRSF) for the construction of the following:
