A RESOLUTION EARNESTLY REQUESTING THE DEPARTMENT OF BUDGET & MANAGEMENT FOR THE AVAILMENT OF THE NATIONAL AID TO LOCAL GOVERNMENT UNITS (NALGU) FUND FOR THE CONSTRUCTION OF THE CITY HEALTH BUILDING IN THE AMOUNT OF P800,000.00.

"WHEREAS, the City Health Office in our city is now dilapidated because of so many years of its existence and is already too constricted to take care of its burgeoning patients due to progress of the city;

"WHEREAS, there is now being prepared by the City Engineer a Program of Work, Plans and Estimates for the proposed Ormoc City Health Building amounting to P800,000.00;

"NOW, THEREFORE, on motion of Kagawad Yrastorza, severally seconded by Mga Kagawad Salazar, Fiel and Hermosilla; be it

"RESOLVED, to earnestly request the Department of Budget and Management for the availment of the national aid to Local Government Units (NALGU) Fund for the construction of the City Health Office building in the amount of P800,000.00;
