## RESOLUTION NO. 285

A RESOLUTION EARNESTLY REQUESTING THE DEPARTMENT OF BUDGET AND MANAGEMENT FOR THE AVAILMENT OF THE NATIONAL AID TO GOVERNMENT UNITS (NALGU) FUND FOR THE IMPROVEMENT OF THE MARKET COMPLEX IN THE AMOUNT OF ONE MILLION PESOS (P1.0M).

"WHEREAS, the City of Ormoc has progressed rapidly and with it there is a need to use the undeveloped areas of the present public market:

"WHEREAS, the Market Complex needs improvement for the smooth operation in order to increase revenues for the city;

"WHEREAS, the City Government of Ormoc would like to avail of the NALGU Fund for the improvement of said complex;

"WHEREAS, there is now being prepared by the City Engineer a Program of Work, Plans and Estimates for this project amounting to approximately one million pesos;

"NOW, THEREFORE, on motion of Kagawad Yrastorza, severally seconded by Mga Kagawad Salazar, Subingsubing and Hermosilla; be it

"RESOLVED, to earnestly request the Department of Budget and Management for the availment of the National Aid to Local Government Units (NALGU) Fund for the improvement of the Market Complex in Ormoc City in the amount of One Million Pesos (P1.OM);

"RESOLVED, FURTHER, to furnish a copy of this resolution each to the Honorable Secretary of Budget & Management, Manila for his favorable
