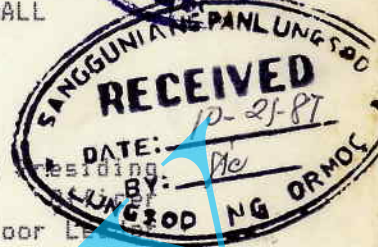

RESOLUTION NO. 291

A RESOLUTION EARNESTLY REQUESTING THE DEPARTMENT OF LOCAL GOVERNMENT FOR THE AVAILMENT OF NATIONAL AID TO LOCAL GOVERNMENT UNITS (NALGU) FUNDS UNDER THE INTER-AGENCY COMMITTEE (IAC) FOR THE CONSTRUCTION OF SCHOOL BUILDINGS OF ONE CLASSROOM EACH AT BARANGAYS SABANG BAO, LIBERTY, MABATO AND CAN-UNTOG, P55,000.00 EACH; CONSTRUCTION OF FOOTBRIDGE AT BARANGAY MONTERICO, P200,000.00; CONSTRUCTION OF BOX CULVERT AT BARANGAY GREEN VALLEY, P200,000.00; AND REPAIRS OF FOUR (4) CLASSROOMS OF P15,000.00 EACH, TWO (2) AT BARANGAY BALION AND TWO (2) AT BARANGAY SALVACION.

"WHEREAS, Barangays Sabang Bao, Liberty, Mabato and Can-untog still need one (1) classroom each, to safeguard the health of their respective pupils;

"WHEREAS, Barangay Monterico has been separated by the wide Pagsangaan river so that there is a need to install footbridge to enable the residents therein to easily transport their produce, products and foodstuff from their farms to market even as vehicles having difficulty in crossing due to the width and unstable condition of the river bed;

"WHEREAS, Barangay residents of Green Valley have manifested that since time immemorial they have been clamoring for box culvert to bridge the river between Barangay Green Valley and Esperanza for the convenience of barangay people including its neighboring barangays;

"WHEREAS, two (2) classrooms each of Barangays Balion and Salvation also need repairs which amounts to P15,000.00 each barangay;

"WHEREAS, there is now being prepared by the City Engineer Program of Works, Plans and Estimates for these different projects amounting to P680,000.00;

"NOW, THEREFORE, on motion of Kagawad Yrastorza, unanimously seconded; be it

"RESOLVED, to earnestly request the Department of Local Government for the availment of national aid to Local Government Units (NALGU) funds under the Inter-Agency Committee (IAC) for the following projects of different barangays of Ormoc City, to wit:


