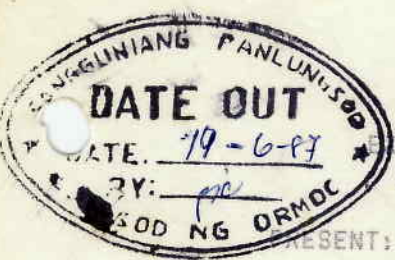

RESOLUTION NO. 302

A RESOLUTION GRANTING THE REQUEST OF THE PROPRIETOR, NADONGHOLAN COCKPIT, WITH OF COURSE THE FAVORABLE APPROVAL BY THE OFFICER-IN-CHARGE, PHILIPPINE GAMEFOWL COMMISSION, TACLOBAN CITY, TO HOLD A "PINTAKASI" ON DECEMBER 17, 18 AND 19, 1987, FOR PURPOSES OF RAISING ADDITIONAL FUNDS TO HELP DEFRAY THE EXPENSES OF AREA V'S SELECTED BOY SCOUTS TO PARTICIPATE IN THE FORTHCOMING BOY SCOUT WORLD JAMBOREE TO BE HELD IN AUSTRALIA SOMETIME IN THE MONTH OF DECEMBER THIS YEAR.

"WHEREAS, Mr. Pelagio T. Brazil, Jr., in his capacity as Vice-Chairman, Area V Scouting Committee, on October 26, 1987, has communicated to Mr. Claudio P. Larrazabal, Proprietor, Nadongholan Cockpit, among others, requesting that the Area V Scouting Committee be allowed to sponsor a 3-day 'Pintakasi' in said cockpit on December 17, 18 & 19, 1987 for purposes of raising additional funds to help defray the expenses of Area V's selected Boy Scouts to participate in the forthcoming Boy Scout World Jamboree to be held in Australia sometime in the month of December this year;

"WHEREAS, on same date, the Proprietor of the Nadongholan Cockpit acting on said letter-request, in turn, made a communication addressed to the Honorable Members of this august Body, through the Honorable OIC-Mayor Euterio V. Larrazabal respectfully requesting to grant Nadongholan Cockpit to hold said 'Pintakasi' on the dates specified therein;
