RESOLUTION NO. 304

A RESOLUTION EARNESTLY REQUESTING THE HONORABLE REGIONAL DIRECTOR, BUREAU OF POSTS, TACLOBAN CITY, TO CAUSE THE TRANSFER OF THE ORMOC POST OFFICE FROM THE SECOND FLOOR TO THE GROUND FLOOR OF THE ORMOC CITY SHOPPING MALL.

"WHEREAS, Kagawad Hermosilla has manifested that his attention has been called by some members of the Consumer's Association that the location of the present Post Office is inconvenient to the public especially the senior citizens of which, to cite an instance, there was one old man who fainted on the way up because there are two flights of stairs to commute to the present post office on the second floor;

"WHEREAS, the Postal Personnel are amenable and more than willing to transfer their office to the ground floor of the Shopping Mall;

"WHEREAS, if this transfer will soon be realized it would be very easy for the public especially those who are disabled or weak, to transact business with the Ormoc City Post Office;

"WHEREAS, it is imperative to ask the kind intercession of the Honorable Regional Director to cause the immediate transfer of the Post Office of Ormoc City from its present location in the second floor to the ground floor in the interest of public service;

"NOW, THEREFORE, on motion of Kagawad Hermosilla, seconded by Kagawad Subingsubing; be it

"RESOLVED, to earnestly request the Honorable Regional Director, Bureau of Posts, Tacloban City, to cause the transfer of the Ormoc Post Office from the Second Floor to the ground floor of the Ormoc City Shopping Mall;


"RESOLVED, FURTHER, to furnish a copy of this resolution each to the Honorable Regional Director, Bureau of Posts, Tacloban City, for his immediate
