RESOLUTION NO. 307

A RESOLUTION EARNESTLY REQUESTING USAID TO SUPPLY/DONATE TO THE CITY OF ORMOC ONE ELECTRICAL POWER GENERATOR OF 220 VOLTS, AT LEAST 50 KVA FOR USE OF THE SANGGUNIANG PANLUNGSOD AND CITY HALL IN CASE OF BROWNOUT.

"WHEREAS, it has been observed that Ormoc City has been experiencing so many brownouts which happens abruptly anytime;

"WHEREAS, some residents of Ormoc City have complained that when brownouts occur business transactions in government offices in the city are inconvenienced;

"WHEREAS, this august Body would like to avail of any assistance from the USAID to supply/donate one electrical power generator of 220 volts, at least 50 KVA for the Ormoc City's smooth government operation, considering that the city is not prepared to purchase the same;

"NOW, THEREFORE, on motion of Kagawad Hermosilla, unanimously seconded; be it

"RESOLVED, to earnestly request the USAID, Manila to supply/donate to the City of Ormoc one electrical Power Generator of 220 volts, at least 50 KVA for use of the Sangguniang Panlungsod and City Hall in case of brownout;

"RESOLVED, FURTHER, to furnish a copy of this resolution each to the USAID, Manila for their immediate consideration and approval; the Honorable City Mayor; the City Treasurer and the City Engineer; all in Ormoc City;
