"WHEREAS, it has been observed that Ormoc City has been experiencing so many brownouts which happens abruptly anytime;

"WHEREAS, some residents of Ormoc City have complained that when brownouts occur business transactions in government offices in the city are inconvenienced;

"WHEREAS, this adjust Body would like to avail of any assistance from the USAID to supply/donate one electrical power generator of 220 volts, at least 50 KVA for the Ormoc City's smooth government operation, considering that the city is not prepared to purchase the same;

"NOW, THEREFORE, on motion of Kagawad Hermosilla, unanimously seconded; be it

"RESOLVED, to earnestly request the USAID, Manila to supply/donate to the Pity of Ormoc one electrical Power Generator of 220 volts, at least 50 KVA for use of the Sangguniang Panlungsod and City Hall in case of brownout;
