A RESOLUTION EARNESTLY REQUESTING THE HONORABLE REGIONAL DIRECTOR, DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS TO TRANSFER WITHOUT COST ALL THE MATERIALS REMOVED FROM THE DETOUR BRIDGES AT PANALI-AN AND BAGOMBONG RIVERS TO THE CITY ENGINEERING OFFICE TO BE USED FOR THE BARANGAYS AND THE CITY OF ORMOC IMPROVEMENT PROGRAM.

"WHEREAS, there is now an on-going project undertaken by the Hanil Construction replacing the old Panali-an and Bagombong bridges with concrete bridges, thus detour are being constructed to facilitate the constructions;

"WHEREAS, this august Body would like to acquire these materials after the completion of the project to be used for the barangays and the City of Ormoc improvement program;

"WHEREAS, these materials could not be acquired without the kind consideration and immediate approval of the Regional Director, Department of Public Works and Highways, Tacloban City;

"NOW, THEREFORE, on motion of Kagawad Yrastorza, severally seconded by Mga Kagawad Adolfo, Salazar and Hermosilla; be it

"RESOLVED, to earnestly request the Honorable Regional Director, Department of Public Works and Highways to transfer without cost all the materials removed from the detour bridges at Panali-an and Bagombong rivers to the City Engineering Office to be used for the barangays and the City of Ormoc improvement program;

"RESOLVED, FURTHER, to furnish a copy of this resolution each to the Honorable Regional Director, Department of Public Works and Highways, Candahug, Palo, Leyte, the Honorable City Mayor, and the City Engineer, all in Ormoc City;
