## RESOLUTION NO. 315

A RESOLUTION MANIFESTING CONFIDENCE ON THE ADMINISTRATION OF HER EXCELLENCY PRESIDENT CORAZON C. AQUINO AND PLEDGING FULL SUPPORT AND COOPERATION FOR HER LEADERSHIP AND PROGRAM OF GOVERNMENT.

"WHEREAS, during the snap election on February 7, 1986, we have acknowledged Her Excellency President Corazon C. Aquino, as a true and tested Filipino Leader of our country as she, with the Honorable Salvador H. Laurel, assumed as President and Vice-President respectively through "People Power" at the EDSA Revolution staged by concerned Filipino people on February 25, 1986;

during the February 2, national plebescite, we have "WHEREAS, reaffirmed Her Excellency President Corazon C. Aquino's leadership when the Filipino people overwhelmingly approved and ratified by voting YES to the 1980 Constitution of the Republic of the Philippines enabling us to go back to our old form of government which is constitutional democracy;
