RESOLUTION NO. 315

A RESOLUTION MANIFESTING CONFIDENCE ON THE ADMINISTRATION OF HER  
EXCELLENCY PRESIDENT CORAZON C. AQUINO AND PLEDGING FULL SUPPORT  
AND COOPERATION FOR HER LEADERSHIP AND PROGRAM OF GOVERNMENT.

"WHEREAS, during the snap election on February 7, 1986, we have  
acknowledged Her Excellency President Corazon C. Aquino, as a true and  
tested Filipino Leader of our country as she, with the Honorable  
Salvador H. Laurel, assumed as President and Vice-President respectively  
through "People Power" at the EDSA Revolution staged by concerned  
Filipino people on February 25, 1986;

"WHEREAS, during the February 2, national plebescite, we have  
reaffirmed Her Excellency President Corazon C. Aquino's leadership when  
the Filipino people overwhelmingly approved and ratified by voting YES  
to the 1986 Constitution of the Republic of the Philippines enabling us  
to go back to our old form of government which is constitutional  
democracy;

"WHEREAS, Her Excellency President Corazon C. Aquino, even only a  
few months in office as President of the Republic of the Philippines has  
consistently outlined her program of government with national interest  
and welfare of the Filipino people as her primary concern;

"WHEREAS, the Fourth Sangguniang Panlungsod ng Ormoc is committed  
to support her leadership and cooperation for her program of government  
for the well-being of the Filipino people in general and to our country  
in particular;

"NOW, THEREFORE, on motion of Kagawad Fiel, unanimously seconded;

as this Body hereby does, pledge our support on her leadership and




