RESOLUTION NO. 320

A RESOLUTION RECOGNIZING THE TWO (2) NEWLY APPOINTED MGA KAGAWAD
NAMELY: HONORABLES RAM F. CAPAHÍ AND LILIO P. SOBERANO, SR. AND
APPORTIONING THEIR RESPECTIVE COMMITTEES AND DISTRICTS THEREOF TO
BE INCORPORATED IN RESOLUTIONS NOS. 318 (ORGANIZING THE STANDING
COMMITTEES) AND RESOLUTION NO. 319 (APPORTIONING ORMOC CITY INTO
TEN (10) REPRESENTATIVE DISTRICTS) OF THE FOURTH SANGGUNIANG
PANLUNGSOD, PASSED AND APPROVED DURING ITS INAUGURAL SESSION OF
DECEMBER 9, 1987.

"WHEREAS, by virtue of the appointment from the Secretary of Local
Government dated December 1, 1987 designating or appointing Honorables
Ram F. Capahi and Lilio P. Soberano, Sr. Officers-in-Charge (Mga
Kagawad) of the Fourth Sangguniang Panlungsod, replacing the incumbents
thereof who are deemed ipso facto resigned therefrom by reason of their
candidacies for elective local positions in the forthcoming January 18,
1988 elections;

"WHEREAS, on December 9, 1987 during the inaugural session of the
Fourth Sangguniang Panlungsod passed and approved Resolutions Nos. 318
and 319, organizing the standing committees and apportioning Ormoc City
into ten (10) representative districts among the Officer In-Charge,
Office of the Vice-Mayor & Presiding Officer and Mga Kagawad of the
Fourth Sangguniang Panlungsod ng Ormoc;

"WHEREAS, it is imperative to recognize the two (2) additional
newly appointed Officers-in-Charge (Mga Kagawad) namely: Mga Kagawad
Ram F. Capahi and Lilio P. Soberano, Sr. of the Fourth Sangguniang
Panlungsod ng Ormoc;

"NOW, THEREFORE, on motion of Kagawad Ricardo L. Martinez,
seconded by Kagawad Romeo M. Hermosilla; be it

"RESOLVED, to recognize the two additional newly appointed Officers-in-Charge, (Mga Kagawad) namely: Honorables Ram F. Capahi and Lilio P. Soberano, Sr., and apportioning their respective committees and districts to be incorporated in Resolutions Nos. 318 (Organizing the Standing Committees) and 319 (Apportioning Ormoc City into ten (10) representative districts) of the Fourth Sangguniang Panlungsod, passed and approved during its inaugural session of December 9, 1987.
