RESOLUTION NO. 321

A RESOLUTION OF AUTHORITY TO UTILIZE FORTY THOUSAND PESOS (P40,000.00) FROM OUT OF THE 2% BUDGETARY RESERVE OF THE INFRASTRUCTURE FUND BUDGET, REPRESENTING PART OF THE RETIREMENT GRATUITY CLAIM OF ENGR. CRISPIN DELA VICTORIA, FORMER ASST. CITY ENGINEER, CITY ENGINEERING DEPARTMENT.

"WHEREAS, the Asst. Regional Director for and in behalf of the Regional Director Department of Budget & Management, Tacloban City in his review letter dated 08 December 1987 opines that our CY 1987 Infrastructure Fund Supplemental Budget No. 10 in the amount of P313,068.70 duly supported by SP Appropriation Ordinance No. 87-55, 87-56 and 87-58, series of 1987, among others, show substantial compliance with pertinent provisions of PD 477, therefore, deemed operative and enforceable as of the dates fixed thereon for its effectiveness in conformance to Section 23 of said Decree, subject, however to the condition set forth on the fourth paragraph thereof, quote That appropriation of P40,000.00 from the 2% Budgetary Reserve shall be authorized subject to submission of SP Resolution requesting authority to utilize the same, for approval of this office, unquote;

"NOW THEREFORE, on motion of Kagawad Ram F. Capahi, seconded by Kagawad Hermosilla and Kagawad Martinez; be it


