RESOLUTION NO. 328

A RESOLUTION EARNESTLY REQUESTING ENGINEER NESTOR C. PENSERGA, WATERWORKS SUPERINTENDENT II, THAT THE DISTRIBUTION OF WATER FOR BARANGAYS COGON, PUNTA, AND ALEGRIA AREAS BE DONE EVERY SIX HOURS OF THE DAY, SPECIFICALLY ON THE TIME OF 6:00 A.M. TO 12:00 NOON; 12:00 NOON TO 6:00 P.M.; 6:00 P.M. TO 12:00 MIDNIGHT; 12:00 MIDNIGHT TO 6:00 A.M. IN ANY ORDER.

"WHEREAS, per information and feedback gathered by Kagawad Bienvenido B. Lagado from some residents of Barangay Cogon, Ormoc City, the supply and distribution of water in their area is not sufficient or not equal as compared to other areas, like Barangays Punta and Alegria;

"WHEREAS, according to Engr. Nestor C. Penserga, Waterworks Superintendent II, the schedule of distribution of water to these two (2) areas of Barangays Punta and Alegria is done every twelve hours;

"WHEREAS, in fairness to Barangay Cogon it is proper and fitting to change the schedule of water distribution of these areas so that they can avail the equal distribution of water;

"WHEREAS, Mga Kagawad of this august Body agree that the time schedules for these three (3) areas be every six hours in any order as the Waterworks Superintendent may directs;

"NOW, THEREFORE, on motion of Kagawad Bienvenido B. Lagado, jointly seconded by Mga Kagawad Hermosilla and Martinez; be it

"RESOLVED, to request Engr. Nestor C. Penserga, Waterworks Superintendent II, Ormoc Waterworks System that the distribution of water for Barangays Cogon, Punta, and Alegria be done every six hours of the day, specifically on the time, as follows:

(RES. NO. 328)

6:00 A.M. - 12:00 Noon;  
12:00 Noon - 6:00 P.M.;  
6:00 P.M. - 12:00 Midnight; and  
12:00 Midnight - 6:00 A.M.

"RESOLVED, FURTHER, that these scheduled time in the distribution of water in the concerned areas be religiously followed and implemented by the personnel assigned in this particular activity;

"RESOLVED, FINALLY, to furnish a copy of this resolution each to His Honor, OIC-City Mayor; the City Treasurer; the Waterworks Superintendent II, and the Barangay Officials of Cogon, Punta, and Alegria; all in Ormoc City;

"CARRIED UNANIMOUSLY."
