## RESOLUTION NO. 329

A RESOLUTION EARNESTLY REQUESTING ALL SHIPPING COMPANIES THAT ARE AVAILING OF THE PORT SERVICES OF ORMOC CITY, INCLUDING THE PHILIPPINE PORTS AUTHORITY (ORMOC BRANCH), PHILIPPINE COAST GUARD (ORMOC STATION), NEW EAGLE ARRASTRE SERVICES, INC. (NEASI), TO INSTITUTE PROPER PRECAUTIONARY MEASURES ON PUBLIC SAFETY AND CONVENIENCE; PARTICULARLY ON THE TRAFFIC CONTORL OF THE INGRESS AND EGRESS OF PORTERS TO AND FROM THE BOAT, CAUSING DELAYS AND INCONVENIENCE OF THE PASSENGERS IN DISEMBARKING; CONTROL OF THE BOARDING OF NON-TICKET HOLDER-PASSENGERS; PROHIBITION OF AMBULANT VENDORS IN THE SHIP; AND, TO REQUEST THE POLICE DEPARTMENT TO ASSIGN UNIFORMED MEN TO MAINTAIN PEACE AND ORDER, AS WELL AS, DIRECT TRAFFIC CONTROL SITUATION IN THE PORT AREA.

it is of public knowledge that the traffic situation in the port of Ormoc is worsening and already almost out of control for the past decades, thus, obviously had created so many considerable complaints;

"WHEREAS. Honorable Edgardo C. de Loyola, in his tour of duty in the port area of our city, observed that the area is very congested with almost all kinds of physical obstructions, viz: a) the improper filing of cargoes which are sprouting along one side of the pier; b) undisciplined ingress and egress of porters to and from the boat causing impact delays and inconvenience to the passengers in disembarking thereat; c) the littering of ambulant vendors in the boat, taking advantage of the absence of proper check-up authorities;

"WHEREAS, it is about time that this august Body finds ways and means to avoid, if not eradicate, this mal-practice now prevailing in our port area;

"NOW, THEREFORE, on motion of Kagawad Edgardo C. de Loyola, jointly seconded by Mga Kagawad Ram F. Capahi and Romeo M. Hermosilla; be it

RESOLVED, to earnestly request all shipping companies that are actually availing of the port services of Ormoc City, including the Philippine Ports Authority (Ormoc Branch), Philippine Coast Guard (Ormoc Station), New Eagle Arrastre Services, Inc., to institute proper precautionary measures on public safety and convenience in the conduct of their rendering services to the general public; to implement proper traffic control in the ingress and egress of porters to and from the ship to avoid delays and irritant inconvenience to the passengers; to impose strict control of the boarding of non-ticket holder-passengers; to cause prohibition of ambulant vendors in the boat; and to assign thereat, uniformed men to maintain peace and order, as well as, direct proper traffic control in the port area;
