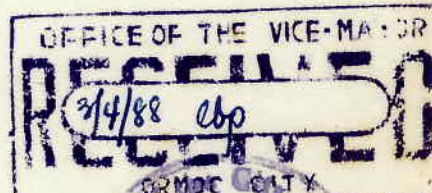

A RESOLUTION TO ADOPT RESOLUTION NO. 2, SERIES OF 1988 OF THE
BARANGAY COUNCIL OF GAAS REQUESTING, IN THIS CONNECTION, THE
COMMITTEE ON INFRASTRUCTURE TO CAUSE THE REPAIR OF THE BARANGAY
ROAD LEADING TO BARANGAY GAAS.

"WHEREAS, the Barangay Council of Gaas in its Resolution No. 2,
Series of 1988 has earnestly and urgently requested the Chairman,
Committee on Infrastructure of this august Body to cause the repair of
the Barangay road to Barangay Gaas, Ormoc City;

"WHEREAS, Honorable Jose B. Conejos in his tour of duty in said
barangay being the Kagawad-in-charge manifested that he personally saw
the bad dilapidated road leading to Barangay Gaas;

"WHEREAS, said resolution states that the bad condition of the road
prejudices the essential services of transporting produce of the area to
the center of commerce in the city which directly and adversely affects
the economic progress of the barangay;

Panlungsod ng Ormoc, all in Ormoc City;


