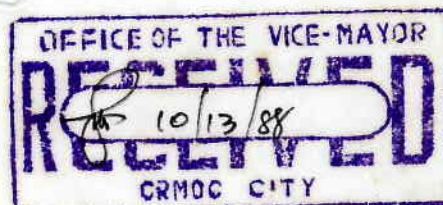

RESOLUTION NO. 102

A RESOLUTION EARNESTLY REQUESTING HER EXCELLENCY, MADAM PRESIDENT
CORAZON C. AQUINO TO INCLUDE ORMOC CITY IN THE APPROPRIATION OF
FUNDS FOR THE CONSTRUCTION OF A JUSTICE BUILDING AT THE GOVERNMENT
CENTER.

WHEREAS, during the conference nationwide conducted by the
Department of Justice of all Regional Trial Judges, no less than Her
Excellency, Madam President Corazon C. Aquino ordered the first release
of a big sum of money allotted for the construction of uniform justice
buildings throughout the country;

WHEREAS, we wish that Ormoc City be included in the appropriation
of funds for the construction of uniform justice buildings and to avail
for the first release thereof, inasmuch as Ormoc City is ready with the
lot which will be taken from the city's government center;

NOW, THEREFORE, on motion of Kagawad Benjamin F. Tugonon,
severally seconded by Mga Kagawad Eufrocino C. Codilla, Jr., Arnulfo C.
Salazar, Antero T. Fiel, and Romeo M. Hermosilla; be it

RESOLVED, to earnestly request Her Excellency, Madam President
Corazon C. Aquino to include Ormoc City in the appropriation of funds
for the construction of a justice building at the city's government
center;

RESOLVED, FURTHER, to furnish a copy of this resolution each to Her
Excellency, Madam President Corazon C. Aquino, Malacanang, Manila, for
her immediate consideration and approval; Her Honor, the City Mayor,
Ormoc City and the City Engineer, Ormoc City;
