

WHEREAS, it has been the policy of the city government of Ormoc to treate a Sports Committee to develop the physical abilities and skills of the youth in the field of sports

WHEREAS, for so many years sports development program in Ormoc City has been solely in the hends of the Department of Education, Culture and Sports, while in other cities the local government unit had long undertaken the devalopment of the youth in the field of sports;
